III. 2011 Salinity Summit

Tina and Esther are still working on locations in San Antonio. The list has been narrowed down to the Sheraton Gunter but a site visit needs to be done. Concern was expressed regarding columns that may interfere with the conference. Esther will conduct a site visit this week. Ed suggested getting a second choice on a location. The date of the 2011 MSSC Summit will be February 17-18, 2011. A suggestion was made to bring in AMTA or Texas AWWA or other partners as co-sponsor for Summit to share costs. Ed will follow up and call Mike Howe with Texas AWWA to discuss. Ed requested to invite GE Water to make a presentation and he will provide contact information to Ernie. - V. The Board was updated by Andy and Warren on the Cal Desal and its formation; this is an advocacy group, specific to ocean desalination with inland desal to be incorporated, that intends to go before the legislature on policies, tax breaks, funding, etc. Donna will find out more information on the group's mission and to obtain more information before the MSSC sends a letter of support. Warren stated that the purpose of this group is to make policies to help improve the environment, and they may have a permanent person on board located in Sacramento.
